#### **COMMUNITY REPORTER**

## **Eligibility**

Members or friends of Messiah who are actively involved in the life and mission of the Congregation are eligible to serve.

#### **Duration of Service**

Approximately 2 hours per week for as long a term as is mutually agreeable to both the person serving and the Witnessing Committee.

# **Scope of Authority**

The Community Reporter is appointed by and responsible to the Witnessing Committee.

The Reporter will provide regular reports to the Witnessing Committee.

# Responsibilities

help build a stronger awareness of Messiah Lutheran Church and its mission to the Camrose Community through regular reporting of interesting congregational events and people.

identify media opportunities which are available in the Camrose community to promote and report on life and activities at Messiah.

identify interesting congregational events/people which would strengthen the profile of Messiah in the community.

solicit information, report on events and people, and submit to local media in appropriate format.

keep the congregation informed of pertinent developments within the community that could possibly impact on the congregation's ministry.

The Congregation will through its staff and committees notify the Community Reporter about events and opportunities to be covered.
