# A Message From Our Synod Bishop

January 2020

Dear Beloved in Christ,

# May grace and peace be yours in abundance (1 Peter 1:2a).

I send you greetings in the Name of the One who is the light of the world, Jesus our Lord, as you gather for your Annual General Congregational Meeting. When you gather together, know that I am filled with gratitude to God for you; that I am thankful for our partnership in the gospel; and, that you continue to be in my prayers as I know I remain in yours.

Since being called to serve as your bishop, October 2012, my prayer has often been the following: O God, you have called your servants to ventures of which we cannot see the ending, by paths as yet untrodden, through perils unknown. Give us faith to go forward with good courage, not knowing where we go, but only that your hand is leading us and your love supporting us; through Jesus Christ our Lord. Amen.

One of the reasons I love this prayer is because it is realistic but encouraging, honest but hopeful. It doesn't deny difficult truths, but neither does it succumb to sterile pessimism. It was written in the first part of the twentieth century by a Church of England priest named Eric Milner-White. Like many good prayers from another time and place, it sounds like it was tailor made for us here and now.

O God, you have called your servants.... When you meet together, you will be making decisions about your priorities for ministry. You will be adopting budgets that enable ministry that joins in God's mission of reconciliation in the world. You will be supporting your partners in ministry – the rostered ministers of this Synod, and especially those who serve among you as they, first and foremost, seek to equip you for the work of ministry: the building up of the Body of Christ.

Joining God's mission means that your ministry is among the people with whom you live and move and have your being. Your ministry is done each day in the living out of your baptismal identity as God's beloved children through your service in word and deed. Ministry continues beyond the neighborhood and congregation through the many faces of the Church and many facets of its ministries: our Synod and its staff, our National Church expression, the Lutheran World Federation, *En Misión con El Salvador: In Mission with El Salvador,* and our Companion Synod – The Evangelical Lutheran Church of Colombia.

O God, you have called your servants.... Since 2012, at Conference/Area Gatherings, in conversations and sharing during Synod Conventions, and two synod-wide Participating in Hope gatherings, Synod Council has been and continues to intentionally listen and to learn. We have gathered these learnings into four statements:

- We are hearing you are desiring connection and relationship to experience God's love among us all.
- You are eager to risk and test new ways but are concerned about how, and want to ensure we keep our essentials.
- You want practical help in discerning what God is up to because you sense God is at work and present in so many ways.
- This sense of God's acting presence is creating renewed desire to be communities of God's hopefilled people.

Perhaps at this year's Annual General Meeting you might reflect on these four statements and our partnership together, as well as name and give thanks for the gifts and mission into which God has invited you and your congregation. Consider taking a few moments in small groups to listen to each other and then share with all gathered reflections on the following (I would be pleased to receive your comments in writing to forward to Synod Council):

- 1) In what way(s) do these four statements reflect our community of faith?
- 2) If we could make three wishes for the future of our Synod what would they be?
- 3) Share about a time or situation when you or your congregation experienced God's love.
- 4) What resources do you have within your community? Share three gifts God has given you.

O God, you have called your servants.... As you meet, I ask you to prayerfully consider forwarding a tithe (1/10th) of your annual income as a congregation as your minimal offering for Benevolence for the ministry of the Synod and through the Synod to the wider Church. Some congregations have exceeded this mark already, but I would encourage all congregations to set this goal.

O God, you have called your servants.... As you gather be sure to join others across the Synod in reviewing the Synod's 2020 Narrative Budget which follows this correspondence. This is our first attempt to present the Synod's Budget to you in a narrative format. I would be pleased to receive your comments in writing to forward to Synod Council. Please note that at the Fall 2020 Congregational Life Event, October 17, in Red Deer opportunity will be provided to equip congregational treasurers and leaders to prepare a narrative budget for your own congregational context.

O God, you have called your servants.... I have seen so many signs of hope in these few years of serving as your bishop, not just in projects and initiatives and ideas, but in our people:

in the faithful and dedicated rostered ministers, who are a gift to us all;

in the diligent and committed staff and officers of the Synod, who it is a joy to work with on a daily and weekly basis, who love the Synod and serving it;

in the lay leaders of this Synod, serving in various and multitude capacities;

in the faithful people who hold no particular office or position, but who form the faithful backbone, week after week, that is the body of Christ in the ABT Synod.

You are all not only living, breathing signs of hope, but you also have my profound thanks for all that you do, and it is my privilege to serve with and among you.

O God, you have called your servants.... My prayer is that your gathering will be a recital of gratitude and praise to God for the signs of the Holy Spirit at work in, through, around, and among you.

The God of hope fill you with all joy and peace in believing, so that you may abound in hope by the power of the Holy Spirit (Romans 15:13).

Gail reported that Dena Grue has agreed to stand for nomination for a two-year term to the Worship Committee.

President Olson made three calls for further nominations. **CM 19:06:04 MSC (David Larson, Lloyd Olson)** that nominations cease and the Nominating Committee's list of names be declared as elected.

**CM 19:06:05 MSC (Gail Stolee, Don Saltvold)** to accept slate of officers as presented and that all elected members be installed in their positions.

President Olson thanked Gail and the Nominating Committee for their diligent work.

Formal **Installation** of those elected will be on Sunday June 16, 2019 at the 10:30 a.m. Worship Service. The **Annual Planning Meeting:** Phase 1 – immediately after the Annual Congregational Meeting (to compile contact information and elect the Chair and Secretary of each Committee); Phase 2 – to be announced later. This meeting involves all members of Church Council and Standing Committee Chairs: Learning, Service, Support, Witnessing and Worship.

# 9. Motion for Signing Authority

**CM 19:06:11 MSC (by Council, Lois Larson)** that any two of the following be appointed to sign cheques for Messiah Lutheran Church: President, Vice-President, Secretary, Treasurer and Bookkeeper.

10 Motion regarding Refugee Support Opportunity: Yvonne Myrehaug requested that Messiah consider support for a family of 4 and a single man as directed to us from CLWR. Both have ties to Camrose. It is likely that we can reduce costs by providing payment in kind as opposed to actual monetary costs. The budget is \$19,379 for the family of 4; but, a relative will provide \$2,000, reducing the cost to \$17,379. Messiah has \$15,000 currently set aside in its refugee fund and Camrose Refugee Centre has \$5,000, so there are sufficient funds available to sponsor the family. The budget for the single man is \$10,019. The goal is to raise funds from other churches, with Century Meadows already considering participating. Other churches with interest in supporting refugees may be approached and other sources for funding are being explored

CLWR needs commitment for funding and all documents by the end of August.

**CM 19:06:12 MSC (Yvonne Myrehaug, Cece Watts)** that Messiah approve sponsorships of the family of four and the single male, subject to having the funds in place as required by Canadian Lutheran World Relief.

# 11. Financial Report and Recommended Budget

Ivar Saugen noted that our audited reports have always been a year behind; this year, the report includes the recommendations regarding our reports.

**CM 19:06:13 MSC (Ivar Saugen, Carol Roy)** to accept the 2017-18 financial statement from our internal audit committee and as reviewed by Grant Thornton.

**CM 19:06:14 MSC (Ivar Saugen, Ron Foshaug)** to approve the recommended budget for 2019-2020 as presented by the Budget Committee with an \$11,277 proposed deficit.

There was a question about how expenses are meet when there is a deficit. Ivar noted that Messiah has had several surpluses recently and reserves have been and continue to be available, including \$75,000 in a GIC for cash reserves. Ivar noted that Council is reviewing options for making better decisions regarding investments in the future. He has prepared a sheet outlining options and Council will bring a recommendation to the 2020 Annual General Meeting.

President Odell thanked Treasurer Ivar Saugen and the Budget Committee comprised of: Don Rebus, LeRoy Johnson, Agnes Hoveland, Sheila Becker, Ivar Saugen and Pastor Calvin Skriver for the Financial Reports and Budget.

Ivar drew attention to the breakdown of expenses and time spent by ministers and staff to help illustrate more accurately where monies are being spent.

# 12. Motions from Council

# 12.1. Bylaw changes

Odell noted that the current bylaws create a lot of cross-coverage between committees. The proposed changes remedy some of these, and Council will encourage better inter-committee communication regarding activities.

**CM 19:06:15 MSC (David Dahle, Ray Blacklock)** to change 7.3 under Witnessing, by removing the first word 'may' and replacing it with 'to'.

**CM 19:06:16 MSC (by Council, Lloyd Olson)** that the Bylaw Changes attached to the Annual Report in Appendix 1 be approved as amended.

# 13. Concluding Remarks

Odell reminded Committees and Council to meet briefly after the meeting to consider Chairs, Secretaries and future meeting times.

Ray Blacklock commented that upon review of reports and congregational observations, he is very impressed with the ongoing life of our congregation. Offered great thanks to the pastors and all the lay staff and volunteers who are doing so much to make the life of our congregation so rich. He noted especially the great activity and support offered by the Messiah Lutheran Women.

- 15. Adjournment: Chair Odell Olson declared the meeting adjourned at 1:50 p.m.

# **PASTORAL REPORTS**

# **Senior Pastor**

# Beloved, do not be surprised at the fiery ordeal that is taking place among you to test you, as though something strange were happening to you.

1 Peter 4:12

Grace and peace to you from God: Father; Son, Jesus Christ; and Holy Spirit.

This text is from the epistle reading for the 7<sup>th</sup> Sunday of Easter of the Revised Common Lectionary. This year, in our worship, we chose texts from Ascension Day instead, but this text from Peter speaks to me as a message for us in this time. We are not in exactly the same situation that the people Peter was writing to were in (we are not suffering for our faith in Jesus), but we are in a period of suffering. I encourage you to read the rest of what Peter wrote in his letter.

This should not be surprising to us. Suffering has always been a part of the human condition and there are many times throughout history when a common suffering has affected the whole of the known world. There have been plagues, famines, floods, earthquakes, storms, and many human made disasters such as war. That we will suffer is certain. The Covid-19 pandemic is one more ordeal in a long line of ordeals for humanity.

What Peter also writes about is that God, in Christ Jesus, shares in our sufferings as we share in what he suffered. We have been joined to God through our baptism into Christ and in our common human experience of suffering. (Peter admonishes his readers – including us – to not bring suffering upon ourselves as the result of doing wrong. Peter lists murder, theft, criminality and "mischief maker". I would suggest that we should be avoiding **any** action or thought that contravenes our duty to love God and love others.)

While we are suffering, we are encouraged to be humble (recognizing that God is so much more powerful than we are and that in due time God will lift us out of suffering). We are called to trust in God and give our anxieties to God because God cares about us. We are to be faithful, resist the devil, and do what we can to stay safe and keep others safe. We are not alone – others also suffer in similar ways.

The promise is that suffering is not the last word. God, in grace, will restore, support, strengthen and establish us. This is most certainly true.

So, how can this message affect us? Well for one thing, we can remind ourselves of all the good things that God has done in our midst in order that we may be able to look forward to the goodness that will happen and continue to happen. There many items in our annual report that reflect the goodness of God's action through faithful hands, feet, mouths and hearts. I encourage you to read through our whole report to help build our confidence in God's providence.

We are not without challenges however. Over the last 4 years, we have consistently spent more money to provide our ministry than we have received in generous donations. Thankfully, God had prepared us for this eventuality with surpluses from years before. But, we are at the end of these surpluses. In this next year, if everything continues as it has been, we will run into deficit. We will need to borrow from our designated funds or from the bank to pay for our regular expenses. We need to make changes.

We have been looking to make changes over the last few years. In this past year we have tried to find ways to generate income from renting parts of our building. We have come close on a couple of occasions to having others renting part of our facilities in times during the week. Nothing has worked out so far.

We have made some changes to the ways we can receive offerings. We have added a debit machine at the back of the sanctuary, recognizing that there are some who rarely use cash or cheques any more. We have begun accepting e-transfers and there are more people who are using automatic deposits from their banks. These steps are looking hopeful at allowing people to give more consistently and generously.

We have been in some preliminary discussions with other ELCIC parishes in our area about ways that we might collaborate. Two parishes currently do not have full time pastoral care (6 congregations). Three parishes (including Messiah) have full time pastoral care. All have been willing to explore how we might strengthen and serve each other in order that we might proclaim the good news in this area more

effectively. Whatever happens, it needs to be for the glory of God, with *mutual* contributions and benefits.

We continue to look for ways to be efficient in the way we run our building and programs of the church. We feel we are at levels that accurately reflect what we will spend in the coming year. Any further cuts will necessarily reduce the service and witness we can provide to the congregation and community. But, if the above measures are not sufficient we will need to find some other way to balance our expenses and income in this next year.

One further complication in all of this is what will be our "new normal" as the result of the covid-19 pandemic. How long will we be unable to gather physically in worship, singing, word, prayer, and sacrament? What will we be able to do together physically when we are able to gather? What will our service look like to the community as we go forward? How will we now witness about God's goodness and grace through Jesus to others who hardly (or don't at all) know Jesus?

Difficulties and suffering are not surprising to us as people of God. At the same time, we know that God is with us every step of the way and is leading us into the fullness of what has been promised through Jesus. Live in humbleness. Live in hope. Live faithfully. And

the God of all grace,
who has called you to his eternal glory in Christ,
will himself restore, support, strengthen, and establish you.
To him be the power forever and ever.
Amen.
(1 Peter 5:10-11)

# **Associate Pastor**

As we come to the close of another fiscal year and the opening of new one, it is a much different world we are in. A pandemic that has not hit our world for many decades is with us. And we are for the first time in a very long time isolating for the safety of people and not meeting together in worship.

We are also in a very different world, where in our isolation we are creating worship for our people online and connections through our website and meeting in the outdoors at safe distance. Much of our pastoral care is by phone or zoom or skype.

This is a challenge our people have not lived for a long time. And yet we remain connected in the Spirit of a very living God who is with us every step of the way. And we are now connected to our world in a way we have not been for many years.

We have sunk into the new norm but are still missing our gathering together to worship and to eat at one table together in communion and over coffee.

Even as things open up in Alberta allowing 50 people to meet, it still remains to be a challenge for our congregation to meet as a whole.

As I look over the last year I have still been a part of caring for our people and the needs of the church and our people in many of the same areas of ministry as I have for many years. This is a ministry shared with our ministry team and each one of you which has definitely shifted over the past few months. This has included worship planning, preaching, worship leadership, preparing for a officiating weddings and funerals, pastoral care and counseling ministry, working with the worship and learning committees, youth and family ministry and doing the regular work of writing, calling, attending committee meetings, synod meetings, ministerial and plura meetings and area gathering meetings. There has also been crisis care with people.

There are new struggles now as people are faced with even more isolation than they have had before the pandemic. As a result, mental health is now a part of pastoral care at an even greater level than before. This means in the last while I have had some situations to give care in that involve family violence and addictions. Our youth are struggling with purposelessness, loneliness and the loss of important moments like their graduations, confirmations and other events. It is possible that they will recover these events later but for now it is a loss with uncertainty as to what will take place.

In addition, I see a spiritual director/supervisor for my own personal and professional growth. This is

very helpful in making sure I stay grounded in my ministry. I also make sure that I take time away with my family as we are able and spend time with them during the week.

One of my main areas of responsibility is teaching and leading confirmation. This means that I am a part of a confirmation leadership team which is a collaboration between Armena, Bethel and Messiah parishes. This is a rich experience as I share in ministry with my partners in this collaborative time together.

Our Youth program is needing some attention. We have a new group coming up from our confirmation whom we will lose if we do not attend to their needs spiritually. This is a vital group of kids that are very interested in their faith journey. It is a challenge because youth are so busy and full in their lives that it is hard to get them to commit to regular attendance at a youth program.

We definitely need to spend some creative time looking at our youth ministry and how we might like to make that flow in a way that meets the needs of our young people in these times. Their needs have changed and yet I believe that they still need some spiritual input in their lives midst they other commitments.

As we move into this next year, we will continue to have some challenges with social distancing and with the world as we begin to open things up again. It will be a joy when life can return to what might be a new norm as we meet again as a whole. It is our hope that we can perhaps collaborate more with other parishes in many areas of our ministry.

I am, as always, very thankful for you as this church thrives because we all share in ministry together. As each one of you take very seriously your call to minister to one another my heart is warmed. Ministry in a church is indeed something we all do together.

I thank God that you join our ministry team in sharing our God's incredible love with the world. Thank you for being such an important part of Messiah's ministry in this world.

We have 8 regular Council meetings per year, no meetings in July, August, or December. Our Pastors Bev Swanson and Calvin Skriver always attend. Devotional leadership at each meeting was shared among the Council members, and the pastors. In April we began to meet electronically in response to the Pandemic.

# **Messiah Council Accomplishments 2019-2020**

We had two Annual Planning Meetings in October at the home of the Larson's with Council, the Committee Chairs, the Seniors group, MLW and the Wednesday Workers. Gail S., Charlene B. and Pastor Calvin asked us to consider how we could:

- A. Continue and grow in our care and inclusion of all people?
- B. Provide for the strengthening the faith of people of all ages?
- C. Encourage service beyond Messiah's door by providing human and material resources?
- D. Use our facility, technology, and finances in a sustainable way to better enhance our ministry and mission and to share in ministry and mission with others?

At the end of the sessions we had three priorities for the future: 1. Collaboration with area congregations 2. Project based ministry including i. Care of Creation ii. Refugee Support iii. Create and Nurture Community Multi-Church Events 3. Improve Faith and Spiritual Practices.

Council and the Committees used these to guide the year's activities. Council and others attended the Area Gathering and the March meeting of area congregations at Bawlf. The Senior Youth Leader position was continued, Pastor Bev kept this and the junior confirmation age program going. Darlene D. and Donny L. worked on starting an "Alpha Program" in a local school. Chris H. was responsible for doing the "Flourishing Congregations" survey in which over 60 people participated. The survey confirmed that of those who participated most had been in the congregation for more than 5 years, were over 50 and were supportive of the leaders and programs of the congregation. Council plans to discuss this with the congregation were delayed by the pandemic. The Learning Committee supported multiple ways to study "Real Faith for Real People" and Witnessing continuing "eating together".

Council also dealt with a number of material issues: we sponsored Jeff Pym of the Evangelical Lutheran Foundation of Eastern Canada to talk about investing our endowment funds; we held a special congregational meeting on December 8 to approve the \$85,000 plus contract to replace most of the flat roofs; we asked the Witnessing Committee for an evaluation of The Messiah Messenger before Pastor

Calvin found a new volunteer editor Dena Grue; we held a special meeting of council on March 3 to discuss the financial situation of the church that decided to i. inform the congregation thru letters and talks of our financial state ii. augment ways to give by putting in an ATM and arranging Interac E transfers iii. inform watchers of the electronic services how they might contribute iv. ask committees and the congregations how we might decrease expenses or raise funds; (This too was interrupted by the pandemic although some of the arrangements helped following closure of the ministry programs.); Pastor Calvin worked on Administrative Assistant succession as Doreen made plans to retire; Ivar and members of the Support Committee kept up the "Moland Cemetery"; we checked into progress on the Flood Insurance issue (no progress); Donny L. obtained quotes to improve the sign on the church lawn; we recommended a replacement for Ruth Jensen on the Neighbour Aid Board; Ivar S. recruited Budget Committee to work with him on the upcoming year's budget: Don Rebus, David Ofrim, Agnes Hoveland, Sheila and Pastor Calvin; Charlene B. formed and led a nominating committee; we reviewed changes that the National Synod is considering for the benefit program of the ELCIC; finally, at the March meeting as the Province was starting to respond to the pandemic the council decided to:


- i. Stop all in building services and hold services and other programs electronically.
- ii. Close the church to the public but keep the office open according to instructions from the Provincial Chief Medical Officer of Health.
- iii. Continue to pay all staff wages.

Council officers and the pastors have continued to adjust and adapt to the issues caused by the pandemic. Regular services and devotionals are sent out on Eastlink and YouTube, the office is open with restrictions, staff and bills are paid and accounts watched. Financially we are doing well, without having to resort to government assistance. We await the year end accounting with some trepidation as at one point we were -\$50,000 for the year.

I would like to thank the Council members and the Committees for all the work they have done. All have done admirably taking on tasks so that the burden is shared, I hope that none found it onerous.

I have been Council President for 6 years; it has been a privilege to serve with this group of dedicated Christians. I will miss many parts of role but feel that it is time for someone with new ideas, new vision, and enthusiasm.

# STANDING COMMITTEE REPORTS

# **Learning Committee**

The Learning Committee met monthly throughout the course of the year. Our committee consisted of Maria Skriver (Chairperson), Dave Stolee (Secretary), Helga Jensen, Dianne Nigh, and Mark Gjesdal. Thank you to all the members of our committee – each one of you brought a unique and valued perspective and skillset. We were also privileged to be joined by Donny Loewen as our Church Council Liaison and Pastor Bev as our representative from staff.

#### **Adult Class**

A large part of our committee's work continues to be planning and scheduling sessions and speakers for Sunday morning Adult Class. Adult Class continues to be our most consistently well attended learning opportunity – with upwards of 50 people on some occasions.

We started off the year with Pastor Calvin facilitating the September Adult Class discussions – including discussing the National Convention, conversations with Muslims in the ELCIC, The Small Catechism – Baptism and Confession, and Bringing a Faith perspective to the Federal election. Thank you, Pastor Calvin. In October, there was a session on "What's next for Messiah?", and Ian Wilson (Director of the Chester Ronning Centre for the Study of Religion and Public Life at Augustana) shared about the Centre and why the Old Testament is important today. In November, we were joined twice by Joan Willoughby and Joy LeBlanc from the Hospice Society, and the Support Committee presented on their responsibilities. December consisted of sharing of Christmas memories (thank you to those that shared), a "Friendship Class Christmas" and a presentation by Ron Grue on his serving through special projects. The World Mission Group & Service Committee then arranged presenters for January and February – thank you to them. We then started our Congregational Book Study (see below) with Pastor Bev leading the Adult Class Sessions on the first three chapters.

Our last Adult Class session for 2019-20 met on March 15<sup>th</sup> and future Adult Class planning was put on hold due to the current pandemic measures. We look forward to when we can meet in person again. If you have ideas for speakers, studies, and/or would like to share your faith story at an Adult Class (or know someone who might), please be in touch with a member of the committee.

# **Congregational Book Study**

Early in the year, the Learning Committee put forth the idea of a Congregational Book Study using the book "Real Faith for Real Life" by Michael W. Foss. The book explores ways we can apply our faith in real life – focusing on six marks of discipleship – Daily Prayer, Bible Reading, Weekly Worship, Christian Service, Relationships that encourage spiritual growth, & Giving in the spirit of generosity.

We decided to "go big" knowing that we could return unused books and ordered 70. Much to our delight, many took interest and all 70 books were dispersed throughout the congregation.

The book study took place over the six weeks of Lent. It consisted of weekly reading (one chapter a week), incorporation in the Sunday church service, discussion during Sunday Morning Adult Class and small group discussion. Thank you to all those that put forth their names to host groups. A big thank you also to our Pastors who embraced the idea, incorporated the themes in the Sunday church services and sermons and led Adult Class discussions.

While the study started out as intended, we were unable to complete it given the change in circumstances this Spring. It is our hope to wrap up the study in the Fall, or whenever we are able to meet in person again. Thank you to all those that participated. Perhaps another congregational book study with a different book will happen in the future.

#### Stewardship

Stewardship continues to be an area of focus for our committee. We recognize that there are many facets of Stewardship. There is stewardship of our land, of animals, of our finances, of our gifts, of our time, of our bodies as temples of the Holy Spirit and the list could go on.

At the start of the year, members of the committee met with Pastor Dave Saude to explore ways we as a congregation could go deeper in what it means to be good stewards of our land. Knowing that there were members of our congregation with an interest in this area, we put forth the idea of creating a "Creation Care" group outside of our committee. This group then started their work.

We had set out this year to do a "Stewardship Month" – with each week focusing on a different form of stewardship. We had planned this for April and May, starting out with the final chapter of our book

study, "Real Faith for Real Life" - "Giving with the spirit of generosity". We were unable to carry out this month as planned – however it is the committee's intent at present to make this a priority for next year.

**Baby Ministry – "Splash" (submitted by Helen Sather)** – thank you Helen for all you do! The SPLASH program is one in which parents of young children receive resources to support their central role in the faith formation of their child. Beginning at baptism, the parents receive monthly newsletters until the child reaches the age of 36 months. These Parent Pages contain ideas on how to share Bible stories, ways to encourage building communication and faith among family members in fun ways, tips to encourage children to pray, helping children to understand and participate in worship, as well as suggestions for building faith and connecting with extended family. Books for reading to the child are also suggested.

As well as the monthly Parent Pages, a music CD featuring singable Sunday School tunes is given at baptism, 13 months, and 25 months.

In the past year, SPLASH newsletters were being sent out to 13 families, 10 of whom are still receiving them currently (April, 2020). These families are not only in the Camrose area, but also from Edmonton (1), Beaumont (1), Wembley (1), Red Deer (1), Vegreville (1), Calgary (1), and Deline, NT (1).

In addition to the Parent Pages and CDs, parents receive letters on the first, second, and third anniversaries of their child's baptism. These letters contain practical suggestions for growing faith at home and within the Messiah family.

Five families who had previously completed the SPLASH newsletter program with older children opted to receive CDs at baptism, and on the first and second anniversaries of their child's baptism. This year, the Learning Committee is also recognizing the first and second baptismal anniversaries of children not receiving CDs with age-appropriate books.

In the past year, 8 first anniversaries were recognized, 7 second anniversaries, and 8 third anniversaries.

Sunday School (submitted by Michelle Kennedy Hawkins) - Thank you Michelle for all you do! The 2019-2020 Sunday School year has been a good one, other than having to stop early this spring due to the pandemic. We continue to have a dynamic crew of volunteer teachers: Kelly Moseson, Steph Enright, Deanna Didriksen, Cheryl Nester, Darlene Dahle, Molly Schulmeister, Hannah Hasselbohm, and myself (Michelle Kennedy Hawkins). The teachers take turns teaching our three age groups: age 3-4, Kgrade 2, and grade 3-6. We also have the joy of Emma Gjesdal leading us in songs at the start of our downstairs time on Sundays. Generally, we have around 15 children attend on a Sunday, but it has varied from around 8 to 20. We are very blessed that our Sunday School teachers are flexible and can adjust their lesson plans to suit the number of children in their class each Sunday. On Sundays we begin our church time upstairs with the congregation for the first 15 minutes or so. After a children's time story/discussion at the front of the church, usually with one of the pastors or with Kelly, we go downstairs for our high energy songs-time with Emma. On our way out of our large singing room we pick up our delicious snacks which we either eat in our classrooms or movie theatre room. Thank you VERY much to our wonderful snack providers!!!!! The children truly enjoy the delicious snacks - they look forward to them every Sunday morning. We find the snacks are also handy with the age 3-4 class as it keeps them happily at the table and paying attention while we read the Bible story of the day. The rest of our class time usually involves activities, discussions, and a short cartoon Whirl curriculum video about the lectionary Bible reading theme of the day. The children then return to their adults upstairs. We usually aim to have them return upstairs in time for communion or around 11:25 a.m. (although if the service is running late and a class is not quite done a project, we may occasionally keep them in class a tiny bit longer to finish up).

Besides our usual Whirl curriculum class-time lessons, we have had some special activities this school year. We have had a couple of Sundays where instead of dividing into classes we keep all the children together for some special crafts or activities. We practiced a play/pageant for the Christmas season. A huge thank you to Darlene Dahle for adapting the script to suit our students, and for coordinating the pageant. In the fall we had a display at the Community Registration night and I handed out invitations to our Sunday School as well as information about how to find our church services on YouTube and our Sunday School page on Facebook. We had thought of doing an event on our church lawn during Jaywalkers, but since Jaywalkers is cancelled we will table that idea and discuss if we want to try it next June.

Other miscellaneous Sunday School notes - our Sunday School space has been made cheerful by bulletin -board displays by Kelly - thanks, Kelly! Loretta Foshaug has continued to be our registrar, order our curriculum supplies, and does a marvelous job keeping our curriculum pages organized for the teachers

- thank you, Loretta! Also thank you to the youth who have assisted in classes occasionally - Caleb Hawkins, Shelby Hasselbohm, and Rhys Didriksen. If I have missed any other youth who have assisted, I apologize. The wonderful MLW has given Sunday School a very kind and generous gift of \$500. So far the Sunday School teachers have been brainstorming ideas by email about how we could best use that money. We have several ideas, so our next step will be to determine which of these ideas to pursue. Thank you, MLW, for giving us this opportunity to make the Sunday School experience even better for our children.

We would love to have another couple of teachers on our teaching roster, especially during the months of December, January, and February. If you might be willing to teach a few Sundays, please contact me at <a href="mailto:mkennedyhawkins@gmail.com">mkennedyhawkins@gmail.com</a> or call or text me at 780-678-5815. If you have a preference of age group or preference of time of year to teach, we are very willing to accommodate that. The Whirl curriculum has easy-to-follow lesson plans to make preparing for class easy, or if you have your own creative ideas for class inspired by the lectionary reading of the day, that is welcomed too.

#### Youth

Pastor Bev continues to oversee youth programming at Messiah, including our Confirmation class. Please see her submission in this Annual Report for an update on this programming.

**Friendship Class (submitted by Donny Loewen)** – Thank you Donny for all you do! The Friendship Class is something I personally enjoy participating in. My role was primarily an assistant, and interacting with the class members.

Cheryl Nester was our teacher, and she always impressed me with her preparedness, enthusiasm and fresh ideas for activities. She is very skilled in having everyone in the class feel included and able to express their thoughts and feelings.

We did however struggle with low attendance all year, which created challenges for the teacher. The attendance ranged from only 1 (which happened numerous times) and occasionally a maximum of 7 or 8 being present.

In late November, there was an illness in the Nester family and Cheryl asked to be excused from teaching. This brought about some anxious moments. We needed someone to step-in and start preparations with the annual Friendship Class - Christmas Pageant. Nora Gilbertson was approached, to see if she could lend a helping hand. Without hesitation Nora graciously accepted and soon began writing and directed the Christmas Pageant. The Friendship Class presented a beautiful Christmas Story. Thank you, Nora.

Cheryl resumed teaching the class in January. We are also grateful for classroom assistance from Lori Skriver and Helga Jensen. Thank you.

Early last fall, it became apparent to club leaders, a shift or change was taking place. Upon some investigation we found, turn-over in staff at the Care Homes, issues with understaffing, which in turn was a major contributor to Friendship members not being present Sunday mornings. We will need to regroup this fall, and revisit continuation of the Friendship Club. If this program is to continue, there would be an urgent need for additional help/assistance, in the classroom and otherwise.

We ask for wisdom and guidance as we seek to be of service in God's kingdom.

# **Small Groups & Studies**

Thank you to David Dahle for leading an in-home study on Acts last fall. A book study for young families met last fall but did not continue due to busy schedules. The Men's Bible Study also continues to meet on Saturday mornings – the men study the lessons for the next day's worship service. There are often 7-9 men in attendance and additional men are most welcome. This group even continued to run via "zoom" this Spring. Lectio Divina (a contemplative and meditative study of the Word open to all) also met prior to the pandemic – thank you to the various facilitators of that group. In addition to the above, three small groups arose for the Book Study. The committee also put forth the idea of doing online groups or bible studies amid the pandemic.

Small groups are a great way to foster deeper connections with each other and in our learning. If you are interested in starting or joining a small group (digitally at present, or in person when safe to do so) – please let the church office know.

# **Multigenerational Events**



# Sharing Jesus Christ, *Cross Culturally*, with all People Annual Report to: Witnessing Committee and Congregational Meeting, May, 2020

"May God be gracious to us and bless us and make his face to shine upon us, that your way may be known upon earth, your saving power among all nations." Psalm 67:1,2

Existing for the purpose of keeping before the congregation Jesus' command to go into all the world with the Gospel, the World Mission Group normally met on the first Monday of each month to study, pray, plan action, and have fellowship.

The Biblical basis for our opening meditation was drawn from several books of the Bible, and from related publications, usually with a mission outreach theme.

Although our most important activity is regularly praying for missionaries, the Group specifically directed its energies to the support of these people and related activities:

- 1. Messiah's most specific connection with a missionary is to Rev. Brian Rude who is serving in his 32st year in El Salvador among marginalized people. Rev. Rude is a full-time missionary of the Alberta Synod. All support for Rev. Rude is through designated givings from Alberta Synod members, from people in other Synods, and from people in the USA. For the period 1/5/2019 through 30/4/2020, individuals in Messiah contributed approximately \$4,970. That amount was enhanced through an additional bequest of \$2,000. Special thanks to Messiah contributors to "In Mission with El Salvador," and through it to the ministry of Rev. Rude. The Synod and Rev. Rude have sent letters of appreciation to Messiah for its support.
- 2. In its 25th Anniversary of organizing World Mission Months, the Group chose the theme, "**Hold Fast** (to Jesus), **Stand Firm** (in the Faith), **Press on!** (to the Goal)" from Phil. 3 and 4 for January, 2020. The sessions attracted between 35 and 45 people to the adult classes in the basement auditorium. A detailed description of the month can be found at the end of this report. The Group acknowledges with appreciation the inclusion in the prayers on Sunday morning of the World Mission Month activities. The cooperation of the Messenger editor in providing good publicity for the Month is also acknowledged and appreciated. In previous years, publicity notes have been distributed to each mail box. But this year, with the cooperation of the Church Office and Audio–Visual staff, announcements of the forthcoming Sunday's program were displayed on the screens for viewers both within the sanctuary and wherever people were watching the Sunday services on their TVs.
- 3. The Group, the congregation through the *Messenger*, and some individuals, have been prayerfully supporting the Watts family in Burundi in their medical and administrative capacities. Some congregational members have also contributed financially to their support. An attempted robbery with violence at their home, with the Corona Virus looming, and with upcoming elections in Burundi, the family came home to Edmonton in April, earlier than had been planned. The Group had the privilege, on May 4, of having a ZOOM connection with George and Susan Watts.
- 4. Ryan and Siobhain Cole serve in Papua New Guinea under "Mission Aviation Fellowship," he as a pilot, she in a "Ground Staff" role. While on home leave, early in 2020, the couple became stranded in Canada due to the corona virus. This was at a time when they wanted to visit congregations. As a substitute for that, the World Mission Group hosted a ZOOM presentation at which the Coles shared what God has called them to be and do in Papua New Guinea.
- 5. The Synod of Alberta is in a "Companion" role with the Lutheran Church in Colombia (IELCO). At Messiah's Annual Meeting, June, 2019 it was agreed to make the interest available from a Mission Endowment Fund for purposes as agreed upon with the IELCO.
- 6. A regular item on our agendas is giving prayerful consideration to one of Messiah's mission priorities, viz. welcoming and helping refugees to settle in Canada.
- 7. For promotional purposes, the bulletin board in the Link features world mission issues. The *Messenger* also contains reports of mission activity, especially from or about Rev. Rude.

We appreciate the support received from the Witnessing Committee as it oversees our activities. We are thankful that we have a yearly allocation of funds to support these activities.

The Chair acknowledges with appreciation the active participation in the World Mission Group of Vincent and Mary Ellen Eriksson, Nora Gilbertson, Doug Hawkins, Erhard Pinno, and Cece Watts. Pastor Calvin's attendance and support are greatly appreciated. With regret, however, Doug has withdrawn from the Group for medical reasons. We also acknowledge with sadness the death of Marie Tveit, a long-time member of the Group in earlier years.

This Group, which is neither appointed nor elected, hereby extends a welcome to others who support its purposes, and would like to share in its activities

My understanding is that one of the families (4 people) were imminently on their way to Canada. This news was at the end of January 2020. We expected them within a month or two. This has not materialized and the covid-19 issues have understandably delayed their arrival.

We have heard nothing much more about the other "family" (one person) other than that they are still in process.

Regarding our previous recent refugees: Jemila Ali remains in Brooks and has married and has a baby from that union. Prayers for them are very much appreciated.

Weini and Yohannes continue to live in Edmonton and have themselves welcomed a new baby to their family. Prayers for them are still appreciated – especially the prayers of thanks for all that Canada has provided for them and that they are contributing to our community.

# Witnessing Committee - Camrose Refugee Centre Report

The Refugee Centre experienced a year of challenge as we encountered new needs in the community requiring different approaches and significant financial resources.

One of the most dramatic situations we have become involved with was a referral from Camrose Adult Learning. A young family suddenly lost their husband and father to a heart attack last May. Because temporary foreign workers have no access to benefits the mother was faced with having her income cut by more than 50% and needing childcare with no access to subsidies. We were referred to City Lights Church where Pastor Milgate invited us to outline the family's circumstances in writing so he could make the situation known to Neighbor Aid. With the help of Neighbor Aid, three congregations, the Thrift Shop and several individuals, we have been able to help the family survive financially until the family qualified for the Canada Child Benefit which workers become entitled to receive after eighteen months of residency in Canada. The mother is now able to support her family and has successfully completed the tests in order to apply for permanent resident status. She and her family will be outstanding contributors to Canada as permanent residents and eventually as Canadian citizens.

We are presently paying the monthly costs for medication for another temporary foreign worker family who have been in need of financial support. We have also helped them make application for support at Neighbor Aid where they were warmly received and supported.

We have started a conversation group once a week at Messiah for newcomers to be able to come to practice their English and to help them start to build a community outside of their own family groups. The need for this kind of opportunity was identified by Tyla Olsen as a result of her work teaching English as a Second Language. Pastor Deborah Ann Taylor of Bethel was also enthusiastic about the formation of the group based on her interaction with newcomers. Elizabeth Bagdan, Sharon Gilbertson, Donny Loewen, Joanne Myrehaug, Erhard Pinno, Ben and Bev Thomas and Cece Watts have all been attending the conversation group. Participation by newcomers has been limited. Although there is enthusiasm for the program, there are scheduling barriers and shyness barriers that are significant challenges to be addressed.

We supported and assisted Una Opela, originally from Botswana, in her collection of clothing for the poorest of the poor in Botswana. Una successfully filled two shipping containers of goods, mainly of clothing, and she and her son personally delivered items to poorest of the poor with the blessing and support of the government of Botswana. Una's goal is to initiate and support building projects to benefit the poorly housed citizens of Botswana going forward.

We are recruiting individuals to volunteer some hours for a single Mom who has qualified for a Habitat house. She has moved into the home but will have some hours to complete once the Restore is able to resume operations following the closure due to Covid 19.

As in the previous two years we partnered with Century Meadows to host a refugee and newcomer Christmas Party at Century Meadows. It is an evening of food and fellowship, the open gym for the children and gifts for every child in attendance.

I am happy to say that in spite of the difficult situations experienced over the years a number of the families we have worked with are functioning successfully enough that their new priority is bringing their relatives and friends to Canada. To that end, we have been experimenting with the formation of Groups of Five to make sponsorship applications. One of the sponsorships was approved prior to the Covid 19 outbreak and two are on hold in order to raise more funds and to assess the impact of Covid 19 on the prospect of bringing family members to Canada.

In addition to the activities described above, support continues for families in day to day life. Assistance with government forms and applications, income tax preparation, transportation to medical appointments, liaison with schools and organizations involved with children, repairs and maintenance of homes, tutoring and other basic needs continue regularly.

The Camrose Refugee Centre Board wishes to thank the many members of Messiah who volunteer their time supporting newcomer families. Last year's annual meeting we opened with this prayer: We are called to practice Courageous Innovation, encourage experimentation, acknowledge our anxieties and be flexible in sharing and deploying financial resources as we evaluate our mission priorities and the barriers to innovation. The reality of these thoughts was certainly a call as to how to prepare this year's budget.

The Budget Committee consisting of Messiah members, Agnes Hoveland, David Ofrim, Don Rebus, staff Pastor Calvin, bookkeeper Sheila, and myself as treasurer met drafting a budget. The draft provided a foundation for Council to be innovative, in particular, to expense side of the budget.

Some expense items could be covered by funds in the Designated Capital Fund as well as some maintenance lines covered by funds coming from debt retirement which was moved into the Capital Fund last year. Thus, creation of Designated Capital Maintenance Fund.


